So, what's with the artists then?

Hands up who's heard about stylists getting into trouble for using art in a photoshoot without copyright permission?

It's not an old wives tale. People have been getting sued for breach of copyright. It's not enough to have insurance we need to be certain that the art we use is 100% good for our shoots.

Clients will pass the responsibility of copyright use in art onto photographers or stylists or whoever is the "weakest link". Contracts from clients may now include that you are responsible for the works being cleared for the kind of photography or filming you're doing - be sure to read the small print.

Enter the Inside Stylists Artists List

We wanted to get together a list of artists who are happy to have their work appear in editorial features in return for a credit and in commercial shoots for a hire fee.

All the artists in this list have put themselves forward and have filled out a form saying that they understand they are doing so to allow us to use them in photoshoots but please double check when contacting an artist down the line that this is still the case. Things change and if you get an email saying they're happy a year after this list has gone live you're probably good to go but always check.



Want to be even more sure?
